PREAMBLE:

In the reference 1st cited, the Chairman, S.A. Raja Pharmacy College, Vadakangulam - 637 116, Tirunelveli Dist., has requested to grant the Letter of Consent of Affiliation for the starting of M.Pharmacy Degree Course in two branches namely Pharmaceutics, and Pharmacology.

2. In the reference 2nd cited, an inspection was conducted on 17.03.2021 to verify the infrastructural, teaching and other facilities available for the conduct of M.Pharm. Degree course. On scrutiny of the inspection report, no specific adverse remark or objection was found. Consequently, Letter of Consent of Affiliation has been issued on 04.05.2021 for starting of M.Pharm. degree course with two branches namely Pharmaceutics and Pharmacology as in the reference 3rd cited.

3. In the reference 4th cited, the Chairman, S.A. Raja Pharmacy College, Vadakangulam - 637 116, Tirunelveli Dist., as requested for grant of Provisional Affiliation to start **M.Pharmacy Degree course** in the branches of Pharmaceutics and Pharmacology along with the approval of the Pharmacy Council of India (PCI), New Delhi.

4. In the reference 5th cited, the Pharmacy Council of India (PCI), New Delhi has granted approval to S.A. Raja Pharmacy College, Vadakangulam – 637 116, Tirunelveli Dist., for 2021-2022 academic year for i) M.Pharm (Pharmaceutics) - 06 seats and ii) M.Pharm (Pharmacology) - 06 seats.

5. In the reference 6th cited, an inspection was conducted on 17.07.2021 for grant of Provisional Affiliation and the Inspection Commission constituted has submitted its report. Scrutiny of the inspection report revealed, No specific adverse remark or objection was found.

6. In the reference 7th cited, the Resolution No. 19, of the 283rd Governing Council held on 27.08.2021 has resolved to grant the order of Provisional Affiliation to S.A. Raja Pharmacy College, Vadakangulam – 637 116, Tirunelveli Dist., for the starting of M.Pharmacy Degree course in the branches of Pharmaceutics and Pharmacology with an annual intake of 06 seats each for the academic year 2021-2022 based on the University inspection reports.

ORDER:

Consequent to the issue of the Letter of Consent of Affiliation, approval of Pharmacy Council of India, New Delhi, University Inspection reports and the approval of the Governing Council, the University grants the Order of Provisional Affiliation to S.A. Raja Pharmacy College, Vadakangulam – 637 116, Tirunelveli Dist., for the starting of M.Pharmacy Degree course in the branches namely Pharmaceutics and Pharmacology with an annual intake of 06 seats each for the academic year 2021-2022.

The Institution has not furnished the DTCP approval and shall arrange to obtain and submit the DTCP approval within 3 months to the University from the date of receipt of this Proceeding.

This order is granted subject to usual terms and conditions which are given in the Annexure.

Any other condition, which the University considers necessary to impose from time to time, should be followed.

ANNEXURE

The Grant of Provisional Affiliation order is granted subject to the following conditions:

1. The admission procedure as laid down in Government order, Health and Family Welfare (MCA1) Department should be followed strictly. The seats available in M.Pharm. Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of admission for the Management quota as per orders in force.
2. The candidates should have been admitted before the cut off date.
3. The Trust should agree for the Inspection of the College by the Tamil Nadu Dr. M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Pharmacy College framed from time to time.
4. The Candidates admitted will take up their 1st year M.Pharm. Degree Examination as per the existing regulations of this University.
5. The Trust and the Pharmacy College should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of syllabus, Examinations, Code of conduct, extracurricular activities, etc.

6. The conditions that may be prescribed by the Pharmacy Council of India, New Delhi shall be fulfilled and the rules and regulations of the central council shall be followed strictly.
7. Only qualified staff shall be appointed to handle the classes in the M.Pharmacy Degree course.
8. No Unqualified staff shall be appointed.
9. Only eligible candidates according to the regulations of this University shall be admitted to the I M.Pharmacy Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
10. The sanctioned strength for said Degree Course should not be exceeded.
11. There shall not be any financial Commitment either to the University or to the Government.
12. Hostel accommodation shall be made available for the students both Male and Female separately.
13. The admission of students should be made after the date of issue of this proceeding.
14. Required furniture shall be provided wherever they are necessary.
15. Furnishing of false information to the University on any approval matter or suppression of facts while furnishing information to the University or Violation of any of the Statutes, Ordinances, Regulations, Rules, instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
16. The Institution shall show evidence of an annual income of not less than Rs. 4,00,000/- (Rupees Four lakhs only) excluding the interest accrued from the Security Deposit mentioned in the statutes to facilitate the proper running of the proposed Pharmacy College.
17. The College shall furnish a "Utilisation Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Pharmacy College.
18. The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the first and second year of the course of study.
19. The Provisional Affiliation now granted by the University is for the first year of M.Pharmacy Degree Course only.
20. After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University by the time only six months period is left for the first year M.Pharmacy Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year M.Pharmacy Degree Course of study.
21. Any other conditions which the University considers necessary to impose from time to time should be followed.
